It was explained that if they are allowed to install an interior fence then it would set a precedence for everyone else to do so as well if desired, it would not be maintained by the Association even though it would join onto existing fence. After much discussion, Dan told them to get more specifications and details from a contractor who would be installing it for further review. This was then tabled for further information from the owner.

Financials

Connie Navarre gave the financial report for November 30, 2020 and the overage report. and there were no questions on the financials. In the month of November, the operating expenses were under budget by \$505.97. Year-to-Date over all expenses are under budget \$370.14.

Collections/Legal

The Board reviewed the legal status report for 1310 Tuam – Ford. She has requested to repay the past due balance in the amount of \$75 per month. The Board feels that the balance is too high to accept a small payment, so is requiring the owner to bring their past due balance current no later than 3/31/2021. Management will advise the attorney.

Management Report

Dan had questions on the order that deed restriction letters are sent. This item will be placed on the January 2021 Agenda for review at that time.
